Further, it is evident that such a reminder system might be useless due to a variety of flaws. Continuous reminders were shown to increase students' awareness, concentration, and organization, all of which contributed to a higher cumulative grade point average.

The tenets of management are as follows: (1) establish goals for the use of resources; (2) develop strategies for achieving those goals; (3) classify activities into categories or departments; (4) define tasks to be done; (5) classify tasks into jobs; (6) assign workers to those jobs; (7) launch work activities; (8) provide incentives to boost productivity; (9) establish controls for measuring achievement of goals and monitoring performance; (10) take corrective actions for unmet goals.

James (2013) emphasized, however, that the ABC Analysis is only one of various priority selection strategies that may be used for effective time management.

Priorities are determined using the ABC Analysis, which divides work into three groups: A, Urgent and Important, B, Important but Not Urgent, and C, Not Urgent or Not Important. In this instance, objectives A and B take precedence. In this regard, suitable quadrant that may be utilized to manage time successfully is listed on Fluent-time Management.com (2013). Here is how you can put the quadrant to use:

Things that belong in Quadrant 1 (Important but not urgent) include things like establishing meaningful connections with others and working toward a goal. These things should occupy the vast majority of a person's attention. In the second quadrant, labeled "Important and Urgent," we find situations like crises and troubleshooting. The typical trinity of occurrences, might distract one from time management and teaching effectiveness. The term "trinity" is used since each of these occurrences has its own definition yet often appears together. Procrastination, paying attention to distractions, and a lack of discipline are all examples of these occurrences. A lack of self-discipline to return one's

concentration to the original task after being distracted by an interruption is a common precursor to procrastination in this setting.

CONCLUSION

Time planning and management are crucial aspects of effective education in secondary schools. When implemented effectively, they can have a significant impact on both students and educators. Effective time planning and management in secondary schools are essential for delivering quality education, reducing stress, and creating a positive learning environment. It requires a collaborative effort among administrators, teachers, and students to ensure that time is used wisely and productively. When done well, it can enhance the overall educational experience and outcomes for all stakeholders in the secondary school community. Based on the discussions, it is clear that the principal places a premium on making efficient use of time in order to guide instructional services and administrative endeavors toward the school's stated goals. The study's findings suggest that principals need a high level of cooperation to ensure that their administrative tasks are completed on time, and that their employees follow the guidelines they set forth for them.

Suggestions

Based on the discussions, the following recommendations are made:

- In order to accurately assign tasks to teachers in a timely manner and maximize teacher productivity, principals should accurately identify activities that call for their participation.
- The school administrators should often ensure that tasks are properly prioritized for give room for effective time management.
- The school administrators should always ensure that daily activities are planned and school time allocated properly.
- Principals should create daily plans that assist students manage their time effectively by include reminders of upcoming tasks they may have forgotten about.
- Reminder setting should be well utilized to avoid ignoring and abandoning any activity assigned to be carried out.
