ABSTRACT

The paper discussed academic staff job satisfaction and quality service delivery in public university. Job satisfaction is the degree to which employees are happy with their work and the overall conditions of their employment. One of the greatest threats to university education in Nigeria is perceived to be academic staff lack of job satisfaction which has cumulated severally to strike actions over the years. Hence, the paper emphasized that academic staff job satisfaction can bring about quality service delivery, by the following; work environment, autonomy and academic freedom, professional development, compensation and benefits, work-life balance, recognition and appreciation, organizational culture, and job security. The paper likewise identified the impact of academic staff job satisfaction on quality service delivery which are: customer satisfaction and loyalty, reduced turnover and service continuity, innovative service solutions, organizational reputation, service perception and quality service climate. It is therefore concluded that recognizing and nurturing the satisfaction of academic staff is not just a campus strategy; it is a key to unlocking the door to outstanding educational outcomes. The paper made some outstanding suggestion that; school administrators should implement recognition and rewards programs to acknowledge the contributions of academic staff to promote a positive and appreciative work culture.

Academic staff job satisfaction is a critical factor in ensuring quality service delivery in higher education institutions, job satisfaction is the degree to which employees are happy with their

work and the overall conditions of their employment (Judge et al., 2001). When academic staff are satisfied with their jobs, they are more likely to be motivated and engaged in their work, which can lead to improved teaching, research, and service delivery.

Ejiogu in Ibara (2010) asserted that motivation is the process by which management enable employees to direct their energies towards maximum attainment of goals and objective of the organization. Ibara (2010) opined that, motivation is an inner force that propels people from inactive state to dynamic action. When organization do not make a proper culture in organization, definitely employees will feel stressed because of bad communication in between employees and their superiors and their performance towards their job will not meet the set standards, staff job satisfaction was positively correlated with student satisfaction and teaching quality.

However, one of the greatest threats to university education in Nigeria is perceived to be academic staff lack of Job satisfaction which has cumulated severally to strike actions over the years. Crisis in Nigerian Universities are consequent upon academic staff dissatisfaction with their jobs.

It has been observed in the recent years that there seems to be lack of dedication and apathy on the part of some academic staff who constitute a key factor in the Nigerian University system. Experience has also shown that many lecturers appear not to be satisfied with their jobs and hence their performances are nothing to write home about. It seems as if there is no commitment to scholarship anymore on the parts of many academic staff in Nigerian Universities. The overall quality of teaching appears to be gradually dropping. Peretomode (2018) opined that teacher's performance in contributing towards learning is strongly influenced by teacher motivation which includes good working conditions, staff training, promotions and good salary and remuneration, participatory decision, job security, recognition of performances and the teaching profession, financial rewards, scholarships and provision of other facilities. These observations were equally majored between the academic staff job performance in Nigeria universities, and proceeding unabated; and this equally evident in frequent strike action embarked on from time to time by universities teacher which almost grounded academic activities. The assumed academic staff poor job satisfaction refers to the teachers' attitudes, perceptions and feelings that they have towards their job. Teachers' job satisfaction could also be seen as to whether teachers are happy with their job or not having indifferent or good feelings about their job, and these qualities are taken to describe a satisfied dimension (Organ, 1997).

An individual's attitude towards their job can either be satisfied or dissatisfied. Job satisfaction is the behavior of an employee to their own work, work situations, collaboration between leaders and fellow employees. Job satisfaction is a positive mind-set, attitude, sentiment, and feeling that individuals may have towards his or her job. Job satisfaction has been linked to productivity, motivation, performance, and life satisfaction (Danish & Usman, 2010). Job satisfaction has been traditionally utilized as a substitute for a desirable organizational outcome. It is always of greater interest to know why people work and at which level they are satisfied with their job so that the leader can focus on areas that mostly satisfy employees. Job satisfaction is an indicator for employees' commitment towards their performance at the working place (Tien, 2018).

The relationship between employee satisfaction and performance where the researcher confirmed that satisfied employees do perform better and contribute to the overall success of an organization, while on the other hand, if employees' satisfaction level is low, the level of performance will drop, and accordingly will affect the success of organization (Martin &

Simmering, 2016). One important strategy to improve job satisfaction and performance is to ensure that the right people are selected for the right jobs because the higher the level of engagement, the more the employee will feel valued at work. This can be achieved through commitment and communication between management and staff. School administrators must be aware of strategies, that can increase job satisfaction such as recognition, advancement growth and promotion work itself and achievement, job satisfaction as a delightful state resulting from evaluation of one's job experience, job satisfaction causes a person to say 'I am satisfied with my job'. Job Satisfaction will refer to good emotional state about teaching as a job that boosts the morale of teachers and maintain their need to stay in the profession, their commitment to the job and their pride of being teachers (George, 2014). Academic staff payment must be looked into, staff are often motivated by more than just money fair compensation, Autonomy, or the ability to make decision about one's own work, recognition for a job will go a long ways in job satisfaction.

According to Ololube (2017), satisfaction and dissatisfaction are driven by different factors. Satisfaction is influenced by motivational factors whilst dissatisfaction is influenced by hygiene factors. The motivators are internal job factors that urge the employees to strive for better achievements, and lead to job satisfaction and higher motivation. They are the factors that influence the feelings of employees about themselves and their work, and motivate them to work harder. Herzberg's Two-Factor Theory of 1959 is one of the most accepted theories which attempt to explain job satisfaction and dissatisfaction.

The concept of job satisfaction does not have a universal definition despite being widely researched by many scholars. Mbua (2013) saw job satisfaction as fulfillment acquired by experiencing various job activities and rewards. Whereas, Robbins (2015) saw job satisfaction as the employee's feeling about his or her job. Job satisfaction is considered to be a function of the perceived relationship between what an individual wants from the job and what the job is offering. People with high level of job satisfaction hold positive attitudes towards their jobs, they feel that they are being fairly treated and believe that their jobs have many desirable features or characteristics such as interesting work, good pay, job security, autonomy and nice co-workers. According to Parsuraman et al. (1998), quality service delivery is determined by the gap between customer expectations and perceptions across various service dimensions.

Job security is associated with overall well-being. Smith and Johnson (2020) recommended that academic staff members who perceive job security as a stable aspect of their employment experience report higher levels of job satisfaction, contributing to their well-being and positively influencing service quality. Job security not only empowers academic professionals but also becomes instrumental in the delivery of high-quality educational services in the ever-evolving landscape of academia.

Factors That Can Hindered Academic Staff Job Satisfaction

Academic staff job satisfaction is pivotal for fostering a positive and productive educational environment. Several factors have been identified in the literature as potential hindrances to job satisfaction, subsequently affecting the quality of service delivery. These factors include:

Lack of Autonomy: Lack of autonomy in education refers to situations where individuals, such as students, teachers, or educational institutions, experience limited independence, self-governance, and decision-making authority. Limited autonomy in decision-making and academic freedom can lead to frustration and reduced job satisfaction among academic staff.

Workload and Stress

Numerous studies highlight the correlation between excessive workload and heightened stress levels among academic staff. Research by Quinn and Turner (2018) found that increased workload negatively impacts job satisfaction, leading to burnout and diminished quality service delivery.

CONCLUSION

Happy faculty members not only shape positive learning environments but also contribute significantly to the delivery of exceptional educational services. - School Administrators should provide academic staff with a degree of autonomy and academic freedom, allowing them to exercise creativity and innovation in their work, thereby increasing job satisfaction and the quality of service delivery.
- School Administrators should cultivate strong leadership that communicates transparently, listens to concerns, and actively involves academic staff in decision-making processes, fostering a collaborative and supportive work environment.
- School Administrators should foster a collaborative and inclusive work environment where academic staff can collaborate on projects, share ideas, and feel a sense of belonging, enhancing job satisfaction and the quality of collaborative service delivery.
