INTRODUCTION

Quality assurance strategies have evolved from a primary concern in business to a fundamental aspect in various sectors, including education and public services. Quality of education has become one of the central issues accorded priority in the recent educational reforms going on worldwide (Arinza, 2013). It became one of the mechanisms used in achieving it. The declining of standard of secondary education in Nigeria poses serious challenge to principals, teachers, and students who constitute the primary focus in quality assurance strategies system. The notion of quality varies from that of providing a distinctive, special or even exclusive product or service, to meeting or conforming to predetermined specifications or standard. To Barineka and David (2019), quality assurance strategies in education has become an all-embracing concept that includes all policies, processes and actions through which the quality of education provided is developed and maintained.

The desire for quality assurance strategies has been considered as a driving force in educational systems across nations of the world, Nigeria in particular. In the bid to ensure quality in education output, quality assurance strategies are considered as one of the vital mechanisms in educational management and it is assumed to be the responsibility of all stakeholders in the educational system (Bush, 2013). It is a way of ensuring that the laid down standards in education policy are implemented, sustained and retained. Consequently, the teachers as important force of quality assurance strategies are a crucial factor for this study.

Quality assurance strategies are enforced due to the consideration that quality education is a sine qua non for socio-economic, political and cultural transformation and development of any nation. As a result, ensuring the quality of the teachers remains paramount. This is considering the fact that teachers are the engine that drives quality in the educational system; they are essential elements in the school organization whose cost effectiveness in maintaining them accounts for over 60% of the total cost of education (Edo & David, 2019).

The emphasis on quality remains paramount as it plays a pivotal role in enhancing the value of products and services. Quality assurance strategies involve continuous assessment and the identification of quality gaps, employing various performance techniques and quality control mechanisms. This comprehensive approach encompasses attitudes, objectives, actions, and procedures that uphold standards and quality control, guided by desirable conditions and strategies for achieving set goals. Moreover, the implementation of quality assurance strategies has not only improved transparency and accountability but has also fostered the generation of new knowledge. Transparency, in this context, is a dynamic concept, whereby quality assurance strategies not only makes institutions transparent but also ensures that the outcomes are shared with all stakeholders. This approach is essential for building trust and fostering a sense of ownership among participants (Ehinder, 2014).

Osuji and Uriri (2022) highlighted that quality assurance strategies mechanisms are driven by various entities, such as Professional Associations, the National Universities Commission (NUC), the National Board of Technical Education (NBTE), the National Commission For Colleges Of Education (NCCE), the National Curriculum Development Centre, Teaching Service Commission, Federal and State Inspectorate Services Department, Nigerian Educational Research and Development Council, and the Teachers' Registration Council of Nigeria (Glasgow Education Services, 2015). These organizations develop strategies to meet expectations by regularly monitoring and supervising educational processes, aiming to meet global standards and competition. In tertiary institutions, quality assurance strategies serve as

effective tools for managing the education system and improving instructional delivery processes. These strategies encompass measurement and standardization of academic programs, evaluation of lecturers' capacities and responsibilities, administrative supervision, dissemination of information, and the development of knowledge policies and practices (Osuji & Uriri, 2022).

The benefits of quality assurance strategies are evident in institutions like the secondary schools and tertiary education, which have implemented strategies to monitor their activities. For instance, WAEC and NECO has recently introduced specific timeframes for tests, examinations, and the submission of meeting minutes, all aimed at achieving predetermined performance goals and objectives in instructional delivery. Responsibility for quality assurance strategies lies with the institution's management, which must develop control measures to monitor teaching and learning processes. This integration of internal and external quality assurance, often involving external examiners and supervisory bodies for accreditation, plays essential role in ensuring educational quality (Uriri, 2019).

Teacher effectiveness is the ability of a teacher to positively impact student learning and development. It encompasses various aspects, including instructional practices, classroom management, communication skills, and the ability to create a supportive and engaging learning environment. The effectiveness of teachers has been a topic of extensive research and discussion in the field of education, because it plays important role in determining the quality of education provided to students (Ololube, 2014; Bardach & Klassen, 2020).

Teaching effectiveness refers to the ability of the teachers to focus on the learners' outcomes, teachers' behaviour, and classroom processes that promotes better learners' outcomes. The question remains that "do the teachers achieve teaching effectiveness in our public schools? Are there things that if well managed or utilized can lead to teaching effectiveness?" Thus, in this context, teaching effectiveness is discussed in terms of classroom management, use of instructional materials, appropriate teaching method and teachers/learners' relationship.

Classroom management refers to the ability of teachers to be able to control the class for teaching and learning to take place. Classroom management involves the organization, maintenance and utilization of the various components of the classroom to enhance teaching and learning. This implies the usage of different methods which a teacher adopts to ensure every learner learn during teaching and learning process to achieve the objectives of the school system (Stronge et al., 2011).

The effectiveness of the educational system therefore depends largely on the productivity of the teachers who are the interpreters and transmitters of desirable attitudes, knowledge, skills and values of the society. Undoubtedly, the dynamic and evolving nature of the educational system requires continuous review and update which demands a corresponding retraining of the teacher in order to meet up with the dynamic educational trend. This ultimately is to make the teacher productive. Training is a systematic process of altering the behaviour, knowledge and skills of the employee to ensure productivity and achievement of organizational goals, whereas, retraining is the process whereby the already trained personnel is exposed to more training for a better or enhanced working ability.

Training of teachers provides them the knowledge, skill, and ability that are relevant to the professional life of a teacher. Teacher training moulds the personality of a teacher such that their attitudes are reshaped, their habits are reformed and their personality is reconstituted through teachers training. As agents of change, principals can promote functional education and improve students' performance in secondary schools through meeting teachers' training needs. The Federal Republic of Nigeria also recognizes the need for the training of teachers when she

declares that education will continue to be given a major emphasis in all educational planning because no education system can rise above the quality of its teachers (FRN, 2014).

Ololube (2014) opined that in this era of knowledge explosion, and emergent knowledge-based economy, staff development should be the priority of any nation that longs for development. Equipping teachers with necessary teaching competencies will contribute to effective implementation of education reforms. The scholar further stressed that the changing classroom practices with technologically changing learning environment require teachers to keep abreast of the global standard of teaching and develop students who can be responsive to societal changes. Bardach and Klassen (2020) succinctly points out that yesterday's good teachers cannot be automatically today's good teachers if they do not upgrade themselves and keep abreast of the trendy concepts and pedagogies in teaching-learning process. Thus, gone are the days when teachers just prepare students for higher education; they need to empower them with relevant skills that can transform them into functional members of the society

Theoretical Framework

Systems Theory

Systems Theory views an educational system as an interconnected and interdependent set of components working together to achieve common goals. In the context of quality assurance strategies for teacher effectiveness, this theory can provide a comprehensive approach to understanding how various factors interact and influence the overall effectiveness of teachers in senior secondary schools (Stronge et al., 2011). Components within the Systems Theory framework relevant to this context include:

Quality assurance strategies can aim to improve these processes through on-going evaluations, feedback mechanisms, and best practice dissemination among educators.

Quality assurance strategies measures seek to align teacher effectiveness with positive student outcomes, emphasizing continuous improvement and accountability.

CONCEPTUAL CLARIFICATION

Quality Assurance

Fasasi and Oyeniran (2014) elucidated the essence of quality assurance strategies as a comprehensive approach encompassing planning, quality control, and improvement to ensure the effective implementation and achievement of efficient instructional delivery processes. According to Fasasi and Oyeniran (2014), quality assurance strategies involve the identification, promotion, and maintenance of the required standards of education or universally accepted benchmarks for measuring efficiency and enhancing accountability. To uphold these standards, universities establish various mechanisms, including the appointment of a director, officers in different faculties/units, quality assurance strategies committees within these faculties/units, and the development of quality assurance strategies manuals tailored to the specific needs of these academic units. These initiatives are aimed at meeting the demands and expectations of both students and society at large.

Arinze (2013) further rationalized the importance of quality assurance strategies in universities, emphasizing its role in maintaining standards and ensuring customer satisfaction, enhancing stakeholder involvement in policy-making, preparing institutions to compete in a competitive market, boosting workers' morale and motivation, creating opportunities for productivity and merit-based recognition. Additionally, Arinze (2013) underscored the significance of performance recognition, enhancing the image and visibility of institutions, attracting donations and grants, and bolstering the recognition and placement of graduates. In essence, when quality assurance strategies is embraced and nurtured, it paves the way for efficiency, competitiveness, and knowledge mobility, private sector engagement in education, increased enrollment, and meeting the demands for relevant and high-quality education.

Okebukola (2016) delineated the distinction between quality assurance strategies and quality control, highlighting their shared objective but differing approaches. Quality assurance comprises proactive and preventive activities that demonstrate an entity's adherence to quality requirements, designed to prevent defects. In contrast, quality control involves reactive and corrective activities aimed at ensuring that quality requirements are met and defects are identified and rectified. Quality assurance strategies employ techniques such as review, training, inspection, and supervision, while quality control relies on techniques like testing and auditing to detect defects.

Supervision is a tool of ensuring quality teaching and learning in schools. It is an internal mechanism adopted by principals for school self-evaluation, geared towards helping teachers and students to improve on their teaching and learning activities for the purposes of achieving educational objectives. The principals ensure effective supervision by interacting academically and socially at a regular basis with teachers and students within and outside the classrooms. The primary aim is to monitor the implementation of curricular and ensure desirable increase in teachers' capabilities, upgrade their conceptual knowledge and teaching skills, giving them

support in their work to facilitate better performance in teachers' pedagogical practices setting (Okoye et al., 2016).

Quality Assurance Strategies

In the educational context, monitoring is a pivotal component of the innovation process. Attentiveness to data and information allows instructional delivery to adopt a more informed approach, tracking the impact of new approaches and making necessary adjustments promptly. This also involves vigilance to unforeseen consequences in the quest for continuous improvement in education. Ololube and Major (2014) pointed to supervision as another strategy for quality assurance, extending beyond mere inspection to encompass efforts aimed at enhancing the quality of instruction. This involves active engagement with staff to advise, grade, refresh, encourage, and stimulate them to improve their instructional practices.

Components and elements of quality assurance strategies in education according to Dangara and Madudili (2021) and Giami and Nwokamma (2019) include:

- **Accreditation and Certification:** Accreditation is a fundamental aspect of quality assurance strategies in higher education. Accrediting bodies assess and verify whether an educational institution or program meets specific standards and criteria. Institutions and programs that meet these standards are granted accreditation, which signifies their quality. Similarly, certifications and licenses are granted to individuals who have met specific educational and professional requirements.
- **Curriculum and Instructional Quality:** Ensuring the quality of the curriculum is essential. This involves designing and maintaining up-to-date, relevant, and rigorous curricula that meet educational goals and standards. Effective instructional methods, pedagogical techniques, and assessment strategies are also part of this process.
- **Educational Leadership and Governance:** Strong leadership and governance within educational institutions are crucial for maintaining quality. Effective leaders establish a

vision for the institution, set policies and procedures, and ensure compliance with quality standards. This includes transparent and accountable management.

- **Staff Quality:** Recruiting, training, and retaining qualified and competent staff is vital for quality assurance. Qualified educators can significantly impact student learning outcomes.
- **Student Support Services:** Providing a range of support services, such as counseling, advising, and academic support, helps students succeed and promotes a positive learning environment.
- **Assessment and Evaluation:** Continuous assessment and evaluation of student performance and institutional effectiveness are central to quality assurance. Data and feedback are used to make improvements and adjustments as necessary.

Effective teachers engage in on-going learning opportunities, such as attending workshops, seminars or conferences, participating in collaborative professional learning communities, or pursuing advanced degrees.

- Policymakers should establish clear expectations for teacher effectiveness and provide teachers with the necessary support to meet these expectations.
