# MANAGING STUDENT ENROLLMENT FOR GOAL ATTAINMENT IN PUBLIC SENIOR SECONDARY SCHOOLS: THE ROLE OF MONITORING AND EVALUATION, AND RESOURCE ALLOCATION PLANNING

#### ABSTRACT

The study examined the role of monitoring and evaluation, and resource allocation planning in managing student enrollment for goal attainment in public senior secondary schools in Rivers State. To achieve the aim and objectives of the study, two research questions as well as two corresponding null hypotheses were formulated to guide the study. This study is underpinned by the Systems Theory. The study adopts a descriptive research design to explore the dynamics of managing student enrollment for goal attainment in public senior secondary schools in Rivers State. The total population is estimated at 6,893 teachers, including 3,490 males and 3,403 female teachers across the public senior secondary schools in the 23 local government areas of Rivers State. To ensure a manageable sample size, 689 teachers, representing 10% of the total population. The sample consists of 349 male teachers and 340 female teachers. Stratified simple random sampling technique was employed to ensure fair representation and eliminate biases, considering teachers from various schools and local government areas. The primary instrument for data collection is a carefully crafted "Goal Attainment Questionnaire (GAQ)". Face and content validation was done by three experts in the field of education and enrollment management. To establish the reliability of the instrument, Cronbach Alpha method was employed. Descriptive statistics: mean and standard deviation, while t-test statics was used to test the null hypotheses at .05 level of significance. The analysis was conducted using SPSS. The study found that monitoring and evaluation and resource allocation planning enhances student enrollment and goal attainment in public senior secondary schools in Rivers State. The study concluded that management of student enrollment is essential and instrumental to goal attainment in public senior secondary schools in Rivers State through monitoring and evaluation and resource allocation planning. The study recommended among others that proper monitoring and evaluation and resource allocation planning will improve student enrollment for effective goal attainment in public senior secondary schools in Rivers State.

Goal attainment within the Nigerian educational landscape embodies the successful realization of specific objectives set within academic institutions such as public senior secondary schools. The process of goal attainment in Nigeria's secondary school educational system involves strategic monitoring and evaluation of students' progress and resource allocation planning. Monitoring and evaluation mechanisms, as highlighted by Lawal (2018), served as crucial tools to assess progress and ensure alignment with set educational goals. Nigerian educational institutions necessitates a multifaceted approach that considers various factors influencing academic success. These factors include student motivation, supportive learning environments, and institutional support structures. Goal attainment within the Nigerian educational context signifies the successful achievement of predefined educational objectives by both students and institutions. It encompasses academic excellence, skill acquisition, and holistic student development, reflecting the collective efforts towards fostering quality education and advancing the educational mission within Nigeria.

This study explored the interconnected elements of enrollment management strategies through monitoring and evaluation and resources allocation panning within Rivers State's public senior secondary schools. Through a synthesis of scholarly literature and empirical evidence, it endeavors to dissect the nuanced impacts of monitoring and evaluation, and resource allocation planning on the predominant goal attainment drive within the education system.

Specifically, the focus is on exploring the effectiveness of enrollment management strategies employed within these educational institutions. This study, aimed at optimizing student enrollment and subsequently enhancing goal attainment, presents complexities and potential obstacles that demand thorough investigation. The core problem revolves around the necessity of understanding and enhancing the utilization of enrollment management strategies within public senior secondary schools in Rivers State. The key challenge involves delicately balancing the elements of enrollment management monitoring and evaluation, and resource allocation to ensure the optimal achievement of goals. Maintaining this equilibrium is crucial for creating an educational environment conducive to meeting established objectives. In response to these intricate challenges, this research endeavor is initiated. Its purpose is to delve deeply into the effectiveness of enrollment management strategies within public senior secondary schools in Rivers State. The primary goals include identifying factors influencing the efficacy of these strategies, assessing their impact on goal attainment, and proposing refined strategies to enhance the enrollment management process. Through this comprehensive investigation, the research aims to make a meaningful contribution to the ongoing discourse on educational reform and improvement within Rivers State's public senior secondary schools. Regularly tracking these indicators allows educational institutions to gauge the impact of their strategies on both quantitative and qualitative aspects of student enrollment. Furthermore, monitoring and evaluation processes contribute to evidence-based decision-making in enrollment management. Smith (2020) argued that relying on empirical data rather than assumptions or anecdotal evidence leads to more informed and effective strategies. In Rivers State, where the socio-economic landscape varies across regions, evidence-based decision-making becomes crucial for tailoring enrollment strategies to the specific needs and challenges of each community. Regular assessments enable enrollment managers to identify successful practices and replicate them while modifying or discontinuing less effective approaches.

In the Rivers State context, characterized by diverse educational priorities and challenges, a robust M&E system is imperative. The utilization of comprehensive data gathered through M&E processes empowers educational institutions to make informed decisions that enhance the overall quality of enrollment management.

Within the Nigerian educational system, where resource constraints and demographic variations are pronounced, the significance of M&E becomes even more pronounced. A well-

established M&E framework allows educational administrators to navigate the complexities of enrollment management with precision (Hossler & Bontrager, 2015). It enables them to identify successful strategies, address challenges proactively, and optimize resource allocation for maximum impact. Moreover, the ongoing nature of M&E aligns seamlessly with the adaptive nature of enrollment management. ### **METHODS**

The study adopts a descriptive research design to explore the dynamics of managing student enrollment for goal attainment in public senior secondary schools in Rivers State. This design allows for a detailed examination of the various components that influence enrollment strategies and their impact on broader educational objectives. The population under examination comprises the teaching faculty in public senior secondary schools across Rivers State. Based on the Rivers

State Senior Secondary School Board (2022), the total population is estimated at 6,893 teachers, including 3,490 males and 3,403 females teachers across the public senior secondary schools in the 23 local government areas of Rivers State. To ensure a manageable sample size, 689 teachers, representing 10% of the total population, was selected. The sample consists of 349 male teachers and 340 female teachers. The stratified simple random sampling technique was employed to ensure fair representation and eliminate biases, considering teachers from various schools and local government areas. The primary instrument for data collection is a carefully crafted questionnaire titled "Managing Student Enrollment for Goal Attainment Questionnaire (MSEGAQ)." This questionnaire consists of two sections: Section A focuses on collecting demographic information, while Section B gathers respondents' opinions on enrollment management strategies. The questionnaire employs a 4-point Likert scale, allowing participants to express their views on a spectrum from 4 = strongly agree to 1 = strongly disagree. Managing Student Enrollment for Goal Attainment Questionnaire (MSEQGAQ) was validated by three experts in educational management. Their corrections were reflected in the final draft of the instrument. To establish the reliability of the instrument, the Cronbach Alpha method was employed. A pilot study involving 20 participants from the study population was conducted, and the reliability index of .730 was obtained. The completed questionnaires were promptly collected on the agreed date to maintain a high retrieval rate, and a total of 689 copies of questionnaires were distributed and a total of 674 copies were retrieved, thereby bringing a total rate of 97%. Descriptive statistics, including mean and standard deviation, were to answer the research questions while t-test statics was used to test the null hypotheses at 0.05 level of significance. SPSS version 23 was used.

### RESULTS

**Research Question One:** How does management of students' enrollment enhance goal attainment through monitoring and evaluation in public senior secondary schools in Rivers State?

The table 3 above showed the difference between the mean scores of male and female teachers on how management of students' enrollment enhances goal attainment in the area of monitoring and evaluation in public senior secondary schools in Rivers State. The mean scores of male teachers is 3.04 and the standard deviation is .86, while the mean scores of female teachers is 3.07 and the standard deviation is .85. The t-test calculated value is .607, the corresponded significance value is .544 showing > .05 at 672 degrees of freedom. Hence, it is concluded that there is no significant difference between the mean scores of male and female teachers on how management of students' enrollment enhances goal attainment in the area of monitoring and evaluation in public senior secondary schools in Rivers State. Therefore, the null hypothesis three is retained at .05 level of significance.

The table 4 above showed the difference between the mean scores of male and female teachers on how management of students' enrollment enhances goal attainment in the area of resource allocation planning in public senior secondary schools in Rivers State. The mean scores of male teachers is 3.19 and the standard deviation is .76, while the mean scores of female teachers is 3.21 and the standard deviation is .75. The t-test calculated value is .458, the corresponded significance value is 0.647 showing > .05 at 672 degrees of freedom. Hence, it is concluded that there is no significant difference between the mean scores of male and female teachers on how

management of students' enrollment enhances goal attainment in the area of resource allocation planning in public senior secondary schools in Rivers State. Therefore, the null hypothesis four is retained at .05 level of significance.

# DISCUSSION

# How management of students' enrollment enhance goal attainment through monitoring and evaluation in public senior secondary schools in Rivers State

Table 1 revealed that management of students' enrollment highly enhances goal attainment in the area of monitoring and evaluation in public senior secondary schools in Rivers State in a positive way. On the other hand, table 3 revealed that there is no significant difference between the mean scores of male and female teachers on how management of students' enrollment enhances goal attainment in the area of monitoring and evaluation in public senior secondary schools in Rivers State. Systematic monitoring and evaluation form the bedrock of effective enrollment management strategies. One of the key aspects of effective monitoring and evaluation is the establishment of clear performance indicators. Adevemi (2020) emphasized that well-defined indicators provide a basis for assessing the success of enrollment strategies. In the context of Rivers State, indicators may include: enrollment rates, demographic diversity, community satisfaction, and academic performance. Monitoring and evaluation in the context of students enrollment go beyond mere data collection; they encompass a systematic and reflective process aimed at understanding the effectiveness of strategies and identifying areas for improvement. In addition, Ololube (2017) outlined the importance of continuous assessment in providing timely feedback to enrollment managers, enabling them to make informed decisions and adjustments. The dynamic nature of educational environments, especially in Rivers State, demands a proactive approach to monitoring and evaluation to address emerging challenges and capitalize on opportunities.

# How management of students' enrollment enhance goal attainment through resource allocation planning in public senior secondary schools in Rivers State

Table 2 revealed that management of students' enrollment enhances goal attainment in the area of resource allocation planning in public senior secondary schools in Rivers State positively. Table 4 on the other hand revealed that there is no significant difference between the mean scores of male and female teachers on how management of students' enrollment enhances goal attainment in the area of resource allocation planning in public senior secondary schools in Rivers State. Financial resources play a pivotal role in resource allocation planning for enrollment management. It is important to note that strategic resource allocation planning is essential for optimizing enrollment outcomes. Hossler and Bontrager stressed the importance of judicious distribution of resources in influencing the efficacy of enrollment management strategies. Furthermore, Adeyemi (2019) highlighted the importance of budgetary considerations in resource allocation, emphasizing that financial planning should reflect the specific needs and goals of public senior secondary schools in Rivers State. #### CONCLUSION

The study examined management of student enrollment for goal attainment in public senior secondary schools within Rivers State, Nigeria. This study revealed an important aspect of monitoring and evaluation in school as feedback from stakeholders. This included students, parents, teachers, and community members. Regularly soliciting feedback through surveys or focus groups provided valuable insights into the strengths and weaknesses of the enrollment process. It also helped build trust and transparency between the school and its community.

Monitoring and evaluation are essential tools for ensuring that resources are being used effectively and efficiently towards achieving goals related to student enrollment and achievement in public senior secondary schools. Regularly assessing progress towards these goals help identify areas where additional resources or support may be needed. It also help to ensure that resources are being allocated in a fair and equitable manner across all student populations.

Resource allocation planning is another critical component of managing students' enrollment for goal attainment in public senior secondary schools. This involves determining how resources will be allocated to support student learning and achievement. Resources included financial resources, such as funding for textbooks or teacher salaries, as well as non-financial resources, such as technology or facilities.

To ensure that resources are being used effectively towards achieving goals related to student learning and achievement. Thus, monitoring and evaluation and resource allocation planning are essential components of managing students' enrollment for goal attainment in public senior secondary schools.

#### Recommendations

Based on the outcome of the findings, the following recommendations were made:

- The student enrollment process should be properly monitored and evaluated in order to achieve the required goal in public senior secondary schools in Rivers State.
- In other to achieve the expected results in student enrollment in public senior secondary schools in Rivers State, the necessary amount of resources should be allocated.
